Annual General Meeting

The Annual General Meeting of DAV Alumni Association was held on 12th Nov, 2017 at the DAV Public School, Lakkar Bazar, Shimla. The agenda included the Election to the new Executive Committee besides the Secretary Report & the Treasurer's financial report. Only 48 members were in attendance.

The meeting started with a Havan at 11.30 AM.

Meeting was presided over by Er. Satish Sagar (President) . Er. S N Kapur (Vice President) conducted the proceedings. Programme started with Gyatri Mantra followed with a tribute to the departed member Sh Avtar Singh Kainth. Er. Ranjit Pun (Secretary) presented the performance report for the past three years followed by Financial Report by Mr. Ravi Thakur (Treasurer).

The Secretary also displayed the slides showing the photographs of all the members batchwise. The photograph of the various events organized & participation by the Alumni Association were also shown to the House. It was informed to the House that the website of the Association will be reactivated in another one week's time.

15 Senior students of 1958 & 1959 batch were honoured and presented with mementos of founder members. One new member of 1959 batch Mr Parvesh Negi also enrolled as Member. His memento will be awarded to him in the next event of the Alumni.

President in his brief address, exhorted all the members not to get discouraged by poor attendance and keep on making sincere efforts in the overall interest of the Association. The President then dissolved the current Executive Committee which had completed its three years tenure as per the Constitution and requested the senior most Alumni Sh Joginder Lal Sood & Sh Prince Mohan Sood to act as Presiding Officers to conduct the elections for the new Office Bearers. The house however unanimously elected the incumbent Office Bearers to hold office for next three years. Consequently the following office bearers were re-elected.

During the deliberations ,the following issues were discussed:-

1. Communication regarding the events: It was a general complaint that all the members are not receiving the information regarding the events. The committee shall look into the reasons for members not getting the messages.
2. It was suggested to invite the desirous members during the Executive Committee meetings.

3. Various measures were discussed to mobilise the new members including Invite Displays on Flex-boards and to run the appeal through the local TV channel. It was informed to the house that a list of around 300 past students of the school has been prepared and shall be hoisted on to the Web site of the Alumni Association so that every member can make efforts to enroll them as members of the Association.

4. It was requested that the pending dues of some of the members on account of change in subscription from Annual Rs 500/- to life time Rs 1000/- may be cleared by them at the earliest.

4. Reluctance of the current members to participate in the events needs to be addressed.

5. It was decided to organize a get together within November 2017.

The house adjourned with national anthem at 2.15 PM. Thereafter the complimentary lunch was arranged by Mr. T.N.Bharat funded from association fund.
